

I am writing in reply to your letter dated September 22, 2009. After careful consideration, I have decided not to turn over contact information for the My Southborough commenter 'Marty'.



We acknowledge your response correspondence of September 30, 2009 which has been carefully evaluated,


The second paragraph of your correspondence suggests that rectification of how the Police Chief Search Committee operated is appropriate to "set the record straight." You then offer a guest post authored by me, as the General Town Counsel of the Town, with other Town Officials to "disseminate the correct information to interested residents." Please note that your proposed offer and comments are flawed in a variety of ways.

First off, there is nothing to rectify as to how the citizen volunteers of the Police Chief Search Committee "operated." They administered their duties in complete conformance with their direction as an ad-hoc Committee to the Board of Selectmen and pursuant to applicable provisions of state statute.

Secondly, offering a General Legal Counsel for the Town the opportunity to guest post may serve your blog purposes, but does not recognize the seriousness of the role or duties of a Government Counsel in regard to this matter. We have been instructed by the Town Officers to investigate certain comments made on your blog as they may be beyond any protected speech commentary.

Clearly inaccurate remarks have been made about Government Officials on a blog administered by you, alleging that a citizen volunteer Committee acted contrary to regulatory state law.

Our duty is to investigate potentially actionable conduct or remarks made on your blog. We strongly suggest that you more closely monitor remarks made on the communication site ensuring that when individuals speak to issues that they do so accurately and without false allegations of violating state law.



More importantly however, this correspondence to you is a notice to preserve all internet addresses, IP addresses and electronic communications of every form as to the comments received relative to the Police Chief Search Committee, including but not limited to those received as to Marty and that no deletions or erasures be made relative to any such data.

We urge you to furnish this correspondence to your own legal counsel who we would be glad to speak with at any time in regard to this matter.
